

Find and Replace Tool For Powerpoint 3.0



Find and Replace Tool For Powerpoint allows you to quickly and easily search and replace across thousands of Powerpoint presentations. Find and Replace Tool For Powerpoint allows all user settings to be saved and opened so that the same tasks can be repeated in the future without re-keying.

Overview

It also has a search-only mode, so you can identify which document(s) contain text that needs to be manually fixed.

Running Find and Replace Tool For Powerpoint

Find and Replace Tool For Powerpoint has two very important pre-requisites when running:

1. Microsoft Powerpoint is not already running (especially with open documents).
2. No documents are opened by someone else (no sharing)

Both these situations lead to file sharing violations. Find and Replace Tool For Powerpoint may appear to hang, and you will need to Alt-Tab to MS Powerpoint to close the 'Open Read Only' dialog box. This leads to our two recommendations when running Find and Replace Tool For Powerpoint:

1. Please close ALL other applications. This ensures that no programs have an Powerpoint document open.
2. If Find and Replace Tool For Powerpoint says that MS Powerpoint is still running, you may have to press Ctrl+Alt+Del to access the Task Manager and kill of all instances of POWERPOINT.EXE manually.

If you are running Find and Replace Tool For Excel across a network, file share or remote machine of any description, you MUST ensure that Find and Replace Tool For Excel has exclusive access to those files.

If you are running Find and Replace Tool For Powerpoint across a network, file share or remote machine of any description, you MUST ensure that Find and Replace Tool For Powerpoint has exclusive access to those files, either through running Find and Replace Tool For Powerpoint if you are guaranteed to have exclusive access, or by denying all users access to the files while Find and Replace Tool For Powerpoint is being run.

Speed and Performance

To get the fastest speed out of Find and Replace Tool For Powerpoint

- Ensure that you disable the virus scanning so that MS Excel can open the documents faster
- Close all other running applications

Trial Version limitations and How to purchase and Register?



A. Adding Files to Process

You need to select the Powerpoint presentation(s), for which you want to run the application. There are three ways, you can select the file for the application:




(a) Scan for Files: Browse and select the folder, which contains the files in the system. If you wish to include the sub-folders in the folder, you can check "Include Subfolder" also.

(b) Get File Names from A Text File: If you have a Text file, which contains all the file names including their path, you can select the text file and the application will select the files to process. There should be only one file name in a line in the Text file.

(c) Parse File Names from a Text: You can manually enter the file names along with their paths in each line.

B. Options





- (a) **Password for Open/Modify:** If you have the password protected Powerpoint file to open or modify, you need to enter the password so that the application can read/modify the file as per your inputs.
- (b) **Log File Name Format:** You can choose the format for naming the log file. There are two formats available: DD-MM-YYYY HH:MM:SS and MM-DD-YYYY HH:MM:SS.
- (c) **Required Find and Replace Count:** Check this box, if you want to view the total no of changes done in the file after running the Find & Replace Tool for Powerpoint.
- (d) **Retain File Dates:** If you don't want to change the Modified date stored in the properties of your Powerpoint file, you may check this box.
- (e) **Backup Mode:** The tool will create a backup file after saving the changes to the new file. In the back-up file, the original file will be saved without any changes.
- (f) **Process Read Only file:** If you want to make changes to 'Read-only' files only, you need to select this check-box.
- (g) **Process Longest "Find What" String First:** You can run the tool basis the length of the string given for the processing. The application will process the longest string first and shortest string at last.
- (h) **Allow Alerts:** During the process, if any alerts messages are coming, you can allow them by clicking at the check-box. This will help you in keeping a check before making any changes to the file.
- (i) **Force to Control CPU Usage:** You can control the process speed. If you go for Fast speed, this application will run faster and other applications currently running on your system will go slow.
- (j) **Revision Document Property Name:** You can increment (by +1.0 or 0.1) your ISO version property here. You can name your property name here. Default is 'Revision'.

(k) Microsoft Powerpoint Control


- **Restart MS Powerpoint after this many Workbooks:** Application use Microsoft Office object model to make changes to your documents. We observed that sometimes its slow down after editing some large number of documents. Here we gave an option where you can restart the Microsoft Powerpoint after your set documents are processed.
- **File Open Delay Timeout Interval:** You can set the Timeout interval for the files. After set time interval if files cannot be open for editing, application skip that file and move to next file.

C. Main Screen



(a) Add Row: Your first step after adding the files will be to add the rows by clicking at  in order to give your inputs to the application.

(b) Delete Row: You can select the row you want to delete and click at  or use Delete key on your keyboard.

(c) Swap Values: You can swap the values mentioned in "Find What" and "Replace With" columns by clicking at .

(d) Find What: The strings, which you want to find in the file(s).

(e) Replace With: The string, with which you want to replace the current string in the file(s).

(f) Search Location: You need to select the location/s in the file(s), where you want the application to find the string. You can select any location among the options given:

- Slides
- Header
- Footer
- Hyperlink Address
- Shapes and Textboxes
- Built-in properties
- Custom Properties
- Links
- Notes
- Slide Master (Per Slide/Presentation)
- Title Master
- Handout Master
- Notes Master

To select the location, you can either select the option from the toolbar by clicking at

 or by selecting the individual Row and click at Search Location column for the respective file.


(g) Search Options: You can select the Search options either directly by clicking at



from the toolbar or by clicking at the search option column in the respective row. There are 3 options available.


- **Match Case:** If you select the Match case, the application will find the string in the given case only. By default, the application is not case sensitive.
- **Match Whole Word:** When you click at this option, the application will search for the string, if it is mentioned as a word in the file and not part of a word. For example, You have a string in a file "Management" and you wish to replace "Manage" to "Administer". If you will select the "Match Whole Word", the application will not replace "Manage" in the word "Management" but will only replace the string "Manage", where this is the whole word itself.
- **Highlight Replacement:** If you want to highlight the shape in the slides, where the changes are done by the application. You can select the option and the color, with which you want to highlight the change(s). You can specify multiple colors for different rows/changes.

(h) Replace Now: After setting all the details in the columns, click at



to start the replacement.

(i) Search Now: If you only wish to execute the Search in the file(s), click at



to initiate the Search.



D. Export

You can export the 'Find What' and 'Replace With' list with other options. List is exported in our own format and in CSV format which you can import when you needed.



E. Import

You can also import list also. If you have list of 'Find What' and 'Replace With' items then you can just save these two columns in CSV file and you can import it here.

F. Process Screen

You can view the files after the processing done by the application.

File Name	Status	Count	Start Time	End time	Errors

(a) View By Files: You can select the view of all the processed files by the file name/Find What string or by Location of the string in the file.

(b) Expand All: Select the file and click at this option, you shall be able to view the expanded form in the pane.

(c) Collapse All: Select the file and click at this option, you shall be able to undo the expanded form in the pane.

(d) Copy Filenames to Clipboard: You can copy the file names with their paths and paste it to any file. You can save the file names in the text file, which could be used for giving the inputs of the files in the form of Text file.

(e) Export: You can export list of files you can see in file grid into text delimited text file. All the columns you can see will be in exported text files separated by a tab.

(f) View Previous Logs: Once you are done with the task in Powerpoint presentations using "Find & Replace Tool for Powerpoint 3.0", you can view the log file. All the changes done are saved in the log folder. Default path for Windows 7 and Windows Vista is

(g) File Name: File names will be displayed in this column.

(h) Status: You can see the current status as Un-Processed/In Process/ Processed in this column.

(i) Count: If you have checked the option of "Required Find & Replace Count" in the Option menu, you shall be able to view the total counts found/replaced.

(j) Start Time: This will display the Start Time in the Time Format of your system.

(k) End Time: This will display the End Time in the Time Format of your system.

(l) Error: If due to any error, the application was not able to perform. You can view the error in this column.
